

Construction Commencement Notice NYES Phase II - Southern Portion PSC Case 19-T-0684

New York Transco anticipates beginning the southern portion of Phase II site preparation and construction of its New York Energy Solution (NYES) Project on or about October 11, 2021.

Project Description and Route

The southern portion of Phase II includes:

Site preparation, construction and restoration for the installation of a new 345kV overhead electric transmission line co-located with reconfigured 115kV transmission lines in an existing electric transmission corridor between a rebuilt Churchtown Switching Station in Claverack and the existing Pleasant Valley Substation in Pleasant Valley. A new Van Wagner Capacitor Bank Station and associated line work will also be constructed in Pleasant Valley.

The map to the right shows the entire Project Route. The southern portion of NYES (in blue) traverses the towns of Claverack, Livingston, Gallatin, Clermont, Milan, Clinton, and Pleasant Valley.

The northern portion of NYES (in orange) includes the towns of Schodack, Stuyvesant, Stockport, Ghent, and Claverack. This portion has been advancing construction since April 2021.

Construction Timeline

Construction is expected to start on or about October 11, 2021 and is estimated to be completed (including restoration) by early 2024. New York Transco will send additional notices with specific timeframes to neighboring landowners and municipalities prior to entering a geographic area.


